SMARTLIFE 120-DAY SATISFACTION ASSURANCE GUARANTEE

**For all SmartStrand® Forever Clean
and EverLux® products**

To the original purchaser of products covered under this guarantee: if, within one hundred twenty (120) days after installation, you wish to change your new carpet for a different style or color, your NFA Godfrey Hirst SmartLIFE carpet retailer will replace it free of charge with another NFA Godfrey Hirst SmartLIFE carpet style or color of equal or lesser value. Should you wish to replace your flooring with a carpet upgrade, you may do so by paying the difference in retail price. No monetary compensation will be paid if a lower priced carpet is selected.

This is a one-time-only replacement and does not include replacement of cushion. Simply contact your NFA Godfrey Hirst SmartLIFE retailer within the time frame of this guarantee and indicate you wish to choose another Godfrey Hirst carpet under the 120-Day Satisfaction Guarantee. This is a satisfaction guarantee and does not apply to matters covered by other warranties. Replacement includes the cost of NFA Godfrey Hirst SmartLIFE carpet only and does not include labor to remove previous carpet, install the new carpet, move furniture, construct permanent built-ins such as cabinets and bookcases, or move or install equipment or electronics. No replacement will be made with respect to carpet that has been subjected to abuse, vandalism, or alteration or damaged by smoke, fire, flood, wind, lightning, or any other casualty event.

LIFETIME ALL OTHER STAINS RESISTANCE LIMITED WARRANTY (Also known as NFA SmartLife Clean Carpet for Life Warranty)

For all NFA Godfrey Hirst® SmartLIFE™ products

For the Warranty Period stated, if your NFA Godfrey Hirst® SmartLIFE™ carpet that is in the NFA Godfrey Hirst SmartLIFE™ or NFA SmartSolutions™ collection becomes stained by substances that are excluded from the standard Stain Resistance Limited Warranty (non-food and non-beverage stains. See the Godfrey Hirst carpet warranty brochure for details), the affected area of the carpet will be repaired or replaced. This coverage is subject to the following conditions:

- The food and beverage stains covered by the standard Stain Resistance Limited Warranty will still be covered during the Warranty Period by that limited warranty for your carpet.
- If the carpet is still noticeably stained after a professional cleaning, we will, at our option, repair or replace the affected area of your carpet under this Lifetime All Other Stains Resistance Limited Warranty (SmartLIFE™).
- During the remaining coverage years following your carpet purchase, the limited warranty covers a percentage of the original purchase price of the carpet depending on when you report the claim to your retailer. Please see proration chart on page 5.
- Godfrey Hirst will not pay any costs associated with removing and disposing of your old carpet. Godfrey Hirst NFA SmartLife warranty will pay labor for installing the replacement carpet. If the identical carpet is not available, a NFA Godfrey Hirst SmartLIFE™ carpet of comparable quality and value must be selected. Comparability in carpet specifications is determined by Godfrey Hirst.
- The Lifetime All Other Stains Resistance Limited Warranty (NFA SmartLIFE™) for your carpet that is in the NFA Godfrey Hirst SmartLIFE™ or NFA SmartSolutions™ collection excludes fading, shading or pile reversal, matting, crushing, wear, odor, burns, water damage, damage from improper cleaning or maintenance, damage from abnormal use or conditions, abuse, vandalism, or damage by smoke, fire, storm, flood, hurricane, wind, lightning, any other natural disaster, or any act of God.

Custom Bound Area Rugs

If you purchased a bound carpet made from a Godfrey Hirst residential wall-to-wall carpet, the limited warranties are valid for bound carpets that are 6'x9' or larger. The limited warranties apply to normal, indoor household use only, and do not apply to labor and materials for binding or serging of the bound carpet. Any replacement under this warranty will be limited to only the carpet, the delivery of the carpet and the removal of the disposal costs related to the carpet being replaced. Binding costs, and other labor charges, and any other charges are your responsibility. If your bound carpet is replaced, this limited warranty only covers one replacement.
